A Bequest to Teen Challenge QLD (TCQ) is an investment into the future generations of people that will be set free from addictions and other life-controlling issues for years to come.

## Types of Bequests

**% Residuary Bequest**  
*is a gift of a percentage of the remainder of your estate* after all your other wishes have been fulfilled and expenses met. Because the value of your gift will rise with inflation it will be worth as much to TCQ tomorrow as it is today.

**📁 Specific Bequest**  
*is a gift of a specific item of value.* For example a painting or property.

**\$ Pecuniary Bequest**  
*is simply a figure of a specific amount of money.*

## How to leave a Bequest

If you already have a Will and want to add a Bequest it is a simple matter of *adding a codicil (amendment)* to your Will.

## Wording for Bequests

“I give to Teen Challenge Care (Queensland) Ltd (ABN 34 097 188 675) in aid of

### a) **General purposes** OR

### b) **The specific purpose of** (Insert here)

- **The sum of \$.....** and/or;
- **Other** (furniture, jewellery, car, shares, life insurance policy etc).
- **The residue of my estate** or
- **A percentage share** of the residue of my estate or
- **All my property** known as (Property Folio Number) situated at (address of property)

I declare that the receipt of the Chairman, President or Treasurer or authorised officer of Teen Challenge Care (QLD) shall be a sufficient discharge to my Executors for my Bequest”.
